ORDER

WHEREAS, Sh. Munish Bhopal, Assistant Engineer (Electrical) was considered for promotion to the post of Executive Engineer (Electrical) by the Departmental Promotion Committee in its meeting held on 05.04.2023. However, owing to pendency of departmental action against him, the recommendations made by the DPC in respect of said officer were placed in a sealed cover;

AND WHEREAS, the Vigilance Department vide their letter dated 20.11.2023 has now issued Vigilance Clearance Certificate in favour of officer, hence, the recommendation of Departmental Promotion Committee in respect of Sh. Munish Bhopal, Assistant Engineer (Electrical), which were placed in sealed cover, has been opened;

AND WHEREAS, on perusal of recommendations placed in the sealed cover, it is found that the Departmental Promotion Committee has recommended the name of Sh. Munish Bhopal, Assistant Engineer (Electrical) for promotion to the post of Executive Engineer (Electrical) on regular basis against the vacancy available in the year 2023 and that in the event of his exoneration in a Departmental case pending against him, the name of Sh. Munish Bhopal may be placed above the name of Sh. Karam Chand (Seniority No. 2) in a panel prepared for promotion to the post of Executive Engineer (Electrical). Since, the promotion order of Sh. Karam Chand, AE (Electrical) was issued vide this department notification of even number dated 21.10.2023, therefore, the promotion order of Sh. Munish Bhopal, Assistant Engineer (Electrical) to the post of Executive Engineer (Electrical) on regular basis is required to be issued from same date; and
