ORDER

WHEREAS, Sh. Eshan Thakur, Assistant Engineer (Civil) was transferred vide notification number PBW-AB(6)-4/2022 dated 05.08.2023 from HPPWD Sub Division Suket to HPPWD Circle Jogindernagar as EO and feeling aggrieved with his transfer, Sh. - 3. THEREFORE, Sh. Eshan Thakur, Assistant Engineer (Civil), who is under order of transfer from HPPWD Sub Division, Suket to HPPWD Circle, Jogindernagar is hereby adjusted/ posted as Assistant Engineer (Q&A) in the O/o Chief Engineer HPPWD Mandi Zone against vacancy, with immediate effect.
