## **MEMORANDUM**

Whereas, Sh. Budh Ram, Junior Engineer (Civil) while posted under HPPWD., Spiti B&R Divn. at Kaza has filed CWP No. 9419/2023 titled as Budh Ram V/s State of HP. The matter was lastly listed before Hon'ble High Court on 28.11.2023 wherein following order has been passed:-

- While deciding the representation, the aforesaid respondent, is directed to take into account, the fact that while extending the benefit of conscession of posting from "tribal to nontribal to soft area", the Norms-Policy, so issued by the State Authorities, should be invariably and uniformly applied without any discrimination, in a cadre. This court hopes and trusts that the. aforesaid respondent, shall take into account this object of the Policy, while deciding the representation.
  - However, in the interests of justice petitioner may not be compelled to join the next place of posting, till disposal of the representation as aforesaid.

As aforesaid, the instant petition, as well as the pending miscellaneous application(s), if any, shall also stand disposed of, accordingly.

And whereas, pursuant to the order passed by Hon'ble High Court, the petitioner made a fresh representation dated 23.12.2023 as received in this office through Executive Engineer, Spiti B&R Division, HP.PWD., Kaza vide his letter No. PW-SD-CB-EA-I/JE/204-9468-69 dated 26.12.2023 for his transfer to one of stations of choice mentioned as under:-
