MEMORANDUM

Whereas, Sh. Chirag Kalia, Junior Engineer (Civil) while posted under HPPWD., B&R Divn. Kalpa has filed CWP No. 10212/2023 titled as Chirag Kalia V/s State of HP. The matter was lastly listed before Hon'ble High Court on 13.12.2023 wherein following order has been passed:-

2. In view of the aforesaid, the petitioner is at liberty to pursue his representation, pending before the concerned authority.

3. In view of the above, present petition is disposed of in the aforesaid terms, so also, pending miscellaneous application(s), if any.

And whereas, pursuant to the order passed by Hon'ble High Court, the petitioner made a fresh representation dated 15.12.2023 for his transfer from HP.PWD., Division Kalpa to HPPWD Division Hamirpur wherein he has submitted that before joining in HPPWD., he was working in IPH Department as JE(Civil) on contract basis and already served in IPH Division Pooh w.e.f. 19.7.2019 to 28.9.2021 for period of 26 months and 9 days.


And whereas, the complete incumbency of petitioner, Sh. Chirag Kalia, JE Civil is as under:-


Since the official has short stay at present place of posting and tenure rendered by him in IPH Deptt. can not be clubbed as after


