


1. The official posted outside the radius of 25 KM are entitled for TTA/ joining time.

4. No promotee has right to forgo the promotion in public interest and promotion can be enforced. In case of non acceptance of reason to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever..

6. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.






