# **Terms and Conditions**

Subject: Hiring of one Number motor vehicle (Scorpio white colour) along with driver for NH Division Rampur.

The Executive Engineer NH Division HPPWD Rampur wishes to hire one Number motor vehicle (Scorpio white colour) along with driver for NH Division Rampur for a period of 6 months on the following terms and conditions.

- 1. This terms and conditions (Annexure-A) shall form the part & parcel of the contract agreement.
- 2. The time allowed for carrying out the service is six months and the same shall be 15 days after issue of LOA.
- 3. The vehicle should be fitted with basic amenities and services.

- 4. The registration fee, payment of route permits, renewal of route permits, payment of all taxes, lavy or toll tax, entry tax at barriers and timely passing of vehicle, will be sole responsibility of the contractor, it will be responsibility of the contractor to obtain the necessary permit to ply the vehicle on restricted/sealed roads(if any).
- 5. The cost of running, repairs, periodic service and repairs of vehicle will be borne by the contractor.
- 6. Penalty of Rs 2000/-per day will be imposed in case of no compliance of Engineer-in-Charge/ Executive Engineer order.
- Contractor shall attend the office of Executive Engineer NH Division HPPWD Rampur within 7 days after issue of the award letter for signing of contract agreement.
- 8. The Driver/Contractor shall keep and maintain the log book of the vehicle, which should be regularly updated. The staff of department using the vehicle will verify the journey in the log book. In case of incomplete log book, it shall be considered that vehicle has not been used by the department.
- The contractor shall not use the vehicle under contract for any other purpose during the contract period i.e. upto 6 months from the date of commencement.
- 10. The head quarter for the vehicle shall be NH Division HPPWD Rampur and can be changed depending upon the requirement of vehicle.
- 11. Driver should have mobile phone in working order with local number for better co-ordination with the Engineer-in-Charge/ Representative of NH Division HPPWD Rampur.
- 12. The contractor shall ensure salary of drivers as per minimum Wages Act.
- 13. The contractor shall deploy driver having valid driving license.
- 14. The contractor shall ensure that the antecedents of the driver are verified by the Police to the satisfaction of the department.
- 15. No payment shall be made for the journeys performed by the driver/owner on account of filling fuel, repairs, services and halt at outstation/headquarter; journey from place of residence to place of duty/place of parking.
- 16. The vehicle should be made available all days as per demand

- 17. Besides normal working hours on all working days, the vehicle should be made available for 24 hours on all the days within half an hour call.
- 18. The vehicle shall be plied on all kind of roads, within and outside Himachal Pradesh including rough and tough roads.
- 19. In case of any breakdown the contractor will provide substitute vehicle immediately, otherwise a penalty of Rs. 2000/- Per day will be imposed and the recovery to this effect will be made from the monthly running bill. In case the contractor fails to provide the vehicle within the scheduled time due to reason beyond his control or due to the force majeure no penalty shall be imposed. However, the payment of these days shall not be made by the department.
- 20. The contractor of the vehicle shall be responsible for compensation payable arising out of accident/payment to third party, if warranted. No compensation in case of accident/damage to vehicle or for death/injury to the driver will be made by the department.
- 21. The losses caused to vehicle due to the negligence on the part of the driver of the vehicle will be borne by the contractor.
- 22. The vehicle should be kept neat and clean and in perfect running condition with adequate quantity of fuel, and should be provided with neat and clean cover/towels. The contractor shall place a Plate at a suitable place on the taxi indicating that the Taxi has been hired for Government Duty.
- 23. It shall be binding on the contractor/service provider firm to provide vehicle from his/its own fleet and if not available then by arranging at his/its own level, failing which performance security/earnest money will be forfeited.
