OFFICE ORDER

On the recommendation of Departmental Promotional Committee, Sh. Sant Ram, Steno-Typist presently working in HPPWD Shimla Divn.No.III is hereby promoted to the post of Senior Scale Stenographer in the Level 11 of HPCS (Revised Pay) Rules 2022 on regular basis with immediate effect in the public interest.

Further consequent upon his promotion to the post of Senior Scale Stenographer, Sh. Sant Ram, is hereby posted in the O/o Engineer-in-Chief, HPPWD Shimla-2 against vacancy with immediate effect in the public interest.

In case the above official desired to fix his pay under FR 22 read with rule 8 of Himachal Pradesh Civil Services Pay (Revised Pay) Rules 2022, he is required to exercise his option within one month from his promotion.


Before the above orders are implemented, the concerned Head of the office will ensure that the promotee fulfill the appended conditions:-

1. The official posted outside the radius of 25 KM are entitled for TTA/ joining time.
2. The above promotee after relieving will join at the place of his posting on promotion within or after availing the joining time as admissible under the rules as given below failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

Distance between the old and the new headquarters	Joining time admissible
30 Km or less	1 day
More than 30 Km	5 days

3. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
4. The above promotion is subject to review due to any consequential administrative reasons.


5. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
6. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.
7. **Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official, if so same may be brought to the notice of this office immediately.**
