"NOTICE INVITING TENDER"

Sealed item/percentage rate tender on form No. 6 & 8 are hereby invited by the Assistant Engineer, Electrical Sub Division, H.P. P.W.D. Tanda on behalf of Governor of H.P. for the following works from the approved and eligible contractors/firms registered with HP PWD (Electrical Wing) so as to reach this office on or before **12-02-2024** up to 10.30 AM and will be opened on the same day at 11.00 AM in the presence of the intending contractors/firms or their authorized representatives. It is also added that if on that day there is a holiday, then the next working day will be taken/considered. The tender forms can be had from this office against cash payment (non-refundable) up to 1.00 PM on **09-02-2024** & it is also added that if on that date there is a holiday, then the previous working day will be taken/considered. The application for the purchase of tender documents should be accompanied with earnest money in the shape of National Saving Certificate/FDR/Call Deposit/Saving Bank Account/ Bank Draft of any Scheduled Bank/Post Office duly pledged in favour of the Assistant Engineer, Electrical Sub Division, HP PWD. Tanda and the application for purchase of tender form should be given with Sr. No. (in words) and Name of Work. Conditional tenders and the tenders received without earnest money will be rejected. The receipt of application for issue of tender forms by post shall not be entertained/ considered in any case. The copy of sales tax clearance certificate shall have to be attached with application form. The ambiguous/telegraphic/ conditional/by fax or by post tenders shall also not be entertained/ considered in any case. The tender shall be issued to only those contractors/firms who are found to eligible, suitable and competent. The decision of the Assistant Engineer, regarding suitability/ eligibility/ competency of contractors/firms shall be final binding on the contractors/ firms applying for issuing of the tender. The offer of the tenders shall be kept open for 120 days. The Assistant Engineer reserves the right to reject the tender without assigning any reasons.

No tender form shall be issued, if the application does not accompany required supporting documents and earnest money.
2. No. person/persons other than the contractor shall be issued tender documents unless he/they hold power of attorney duly registered under law. The tender of those contractors who are registered as dealer under HP Gen Sales Tax Act 1968/ GST and who have cleared all the dues on accounts of tax will be entertained only.
3. A single rate be quoted for every single items of work of otherwise lowest quoted rate would be considered for evaluating the tender. The rates must be quoted in figures as well as in words.
4. Conduit pipe is to be laid simultaneously along with the civil work where applicable.
