**OFFICE ORDER**

On the recommendation of Departmental Promotional Committee, the following Junior Technician/Tech.Gr.II/Tech.Gr.I (Work Inspector) who possess two years regular full time ITI Course in the trade of Surveyors/ Draughtsman (Civil) from an ITI/ Institution duly recognized by the Central or State Government with 8 years regular service or regular combined with continuous ad-hoc service rendered, if any, in the grade are hereby promoted to the post of Junior Engineer (Civil) in the pay scale of Level 11 of HPCS (RP) Rules, 2022 on regular basis with immediate effect in the public interest:-

The officials have to exercise option under F.R.22 read with rule 8 of HPCS(RP) Rules,2022 for the purpose of fixation of his pay against the post of Junior Engineer (Civil) within one month from promotion.

Consequent upon their promotion to the post of Junior Engineer (Civil), the posting orders are hereby ordered with immediate effect in the public interest as under:-

**The above officials may not be posted in their home sub division, if any.**

The officials posted outside the radius of 25 KM are entitled for TTA/ joining time.

Before the above orders are implemented, the concerned Controlling Officer shall ensure that the promotees fulfill the appended conditions:-

1. Before relieving the officials, it may be ensured that above promotees possess two years regular full time ITI Course in the trade of Surveyors/ Draughtsman (Civil) from an ITI/ Institution duly recognized by the Central or State Government with 8 years regular service and also **possesses the National Trade certificate issued by the NCVT.**
2. The above promotees after relieving will join at the place of his/her posting on promotion within or after availing the joining time as admissible under the rules as given below failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

Distance between the old and the new headquarters	Joining time admissible
30 Km or less	1 day
More than 30 Km	5 days

3. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
4. The above promotion is subject to review due to any consequential administrative reasons.
5. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
6. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.
7. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official, if so same may be brought to the notice of this office immediately.
8. **The Controlling Officer(Concerned) shall strictly adhere to the instructions issued by the department of Personnel to the Govt. of HP vide letter No.Per(AP-B)E(3)-17/2022-Part dated 4.09.2023 for implementation of order.**
