OFFICE ORDER

Whereas, Sh. Sanjay Thakur, Senior Assistant while posted in the office of Assistant Engineer, Bharmour Sub-Division, HP PWD Bharmour, District Chamba was transferred and posted in HPPWD Divn. Chamba against vacant post vide this office order No. PBW-B018(109)/2/2025-ESTT.- I (Comp.No.276957) dated 13.11.2025 with the prior approval of competent authority conveyed vide U.O.No. Secy/CM22005/2022-VIP-B-220265 dated 11.11.2025.

Feeling aggrieved against this order the official has filed CWP No. 17914/2025 before the Hon'ble High Court of HP Shimla which has been finally decided and disposed of on 18.11.2025 with the following orders:-

- 3. At this stage, learned counsel for the petitioner fairly submits that petitioner would be satisfied in case he is permitted to make a representation to respondent/Competent authority for the redressal of his grievances, whereafter, respondent /competent authority be directed to consider and decide the same in accordance with law within a time bound schedule.
- 4. In view of the pleadings and grounds urged, petitioner has made out a case of interim relief, however, taking into consideration the fair submissions made by learned counsel for petitioner, this the writ petition is disposed of by permitting the petitioner to prefer a representation respondent to Authority within a week, whereafter, the same shall be considered and decided by the Competent Authority, in accordance with law and as per applicable transfer policy keeping in view the above observations, within three weeks. Copy of decision so taken, be communicated to the petitioner.

Till such time, the operation of office order dated 14.11.2025 (Annexure P-3) shall remain stayed or in other words, petitioner shall be permitted to serve at HPPWD Division Bharmour, District Chamba. It is made clear that in case petitioner does not represent within the aforesaid period, the interim protection granted to him under this order shall automatically stand vacated.

Pending miscellaneous application(s), if any, also stand disposed of.

And whereas, in compliance to above direction of Hon'ble High Court of Himachal Pradesh, the petitioner was summoned for personal hearing on the fixed date 23.12.2025 at 11:00 AM in the chamber of Engineer-in-Chief. On the fixed date, the partitioner appeared in person and made his written as well as oral statement.

And whereas, in his statement the petitioner Sh. Sanjay Thakur, Sr. Asstt. has submitted that his mother is suffering from Heart problems and his wife is also suffering from Migraine decease and as such it is necessity to look after his old aged mother & Wife/family in nearby station of his native home and he may be adjusted in the following station of his choice: -

- 1. HP.PWD Sub-Division Rakh (Non-Tribal area) Under HP.PWD Division Bharmour.
- 2. HP.PWD Sub-Division No.1 Chamba (Non-Tribal area) Under HP.PWD Division Chamba.
- 3. HP.PWD National Highway Sub-Division HP.PWD Chamba Under N.H. Division HP.PWD Chamba (Non Tribal area).
- 4. HP.PWD Sub-Division No.II HP.PWD Chamba (Non Tribal area) Under HP.PWD Division Chamba.
- 5. HP.PWD Division Bharmour
