> The officials posted outside the radius of 25 KM are entitled for TTA/ 1. joining time.

> 2. The above promotees after relieving will join at the place of his/her posting on promotion within or after availing the joining time as admissible under the rules as given below failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.

Distance between the old and the new headquarters	Joining time admissible
30 Km or less	1 day
More than 30 Km	5 days

3. Before relieving, the concerned controlling officer shall ensure that all promotee (s) are 10+2 or its equivalent like Higher Secondary Part-II, Intermediate etc. or above from recognized board/institution.

In case of change of present place of posting of the promotee (s), these 4. orders be dispatched to further to the office concerned under intimation to this office.

In case vacancy is not available, the promotee (s) may not be permitted 5. to join the office and the case may be sent to this office for further orders.

In case of any litigation arises due to non-relieving of the promote(s), 6. the concerned controlling officer shall be liable for the same.

No promotee has right to forgo the promotion in public interest and 7. promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non-acceptance of reason to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.

The above promotion is subject to the review due to any consequential 8. administrative reasons.

Those who have been posted outside the sub-cadre/ Tribal area will 9. have to serve in difficult sub-cadre as and when it is administratively

required.

That in case of any factual error/ omission is detected later on, the 10. promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.

Before relieving the official to join the new place of posting on 11. promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official, if so same

may be brought to the notice of this office immediately.

Before relieving/joining, it may please be ensured that the above 12. official(s) have completed 7 years regular services as Jr.Asstt./Clerk.

The Head(s) of the office(s) concerned shall send relieving/joining 13. reports of the promote(s) to this office immediately.
