No. PWD-A-B0(6)/36/2021-Part-II Dated, Shimla-2, the 24-01-2026

ORDER

WHEREAS, Sh. Surender Pal Sharma, Assistant Architect, was transferred from O/o Chief Architect (CZ) HPPWD Mandi to O/o Chief Architect, HPPWD Shimla vice Sh. Vijay Thakur and vice versa, vide this department notification No. PWD-A-B0(6)-36/2021 dated 08.05.2025 with the prior approval of Competent Authority. In compliance of ibid Government orders, both the officers had joined their duties at new place of posting(s);

AND WHEREAS, Sh. Surender Pal Sharma feeling aggrieved against his transfer made representation dated nil wherein the applicant stated that he is going to retire from service after attaining the age of superannuation on 31st January, 2027 and his parents are old age who are suffering from various old age ailments and undergoing regular treatment & follow up checkups from AIIMS Bilaspur etc.;

AND WHEREAS, the Government vide instructions dated 13.02.2025 inserted new provision as Para 22A after Para 22 and before para 23 of O.M. dated 10th July 2013 which provides as under :-

"22 A. Redressal of grievance on account of Transfer: In case any employee, who is transferred feels aggrieved, should not proceed further to direct approach the Hon'ble Court.

The concerned employee will have to join at the station to which he/ she is transferred / posted within permissible joining time in compliance of the order issued first so as the government / departmental work continues smoothly.

To seek redressal of a grievance, the proper course for him/her is to address the authority who had issued the transfer order in the department in the form of a representation containing points regarding developments or facts having a bearing on his/her

transfer. The issuing Authority shall put up the file with all facts and circumstances to the Competent Authority who had approved the concerned transfer order for resolution of the grievance(s) in a fair and impartial manner in reasonable time on priority by passing a speaking and reasonable order. The action as may be called for, will be ensured **within 30 (thirty) days**.

If the Competent Authority after examination of the representation thoroughly orders for the cancellation of the earlier transfer order in that case the earlier position of posting will be restored. If the transfer order is not cancelled then the original transfer order shall prevail."

AND WHEREAS, as per ibid provisions, the grievances of petitioner were required to be placed with full facts and circumstances to the competent authority who had approved the concerned transfer order for resolution of the grievance(s) in a fair and impartial manner;

AND WHEREAS, he also filed a petition CWP No. 12270/2025 titled as Surender Pal Sharma Vs. State of HP and Ors which was disposed by the Hon'ble High Court on 04.08.2025 with the directions to consider and decide the representation of the petitioner, in accordance with law, within a period of six weeks;

AND WHEREAS, the representation of the applicant alongwith full facts and circumstances alongwith following incumbency was placed before the competent authority who had approved the transfer order of applicant but in the meantime, the applicant also filed Execution Petition before the Hon'ble High Court, which is pending adjudication; The incumbency of the involved officer(s) is as under:-
