MEMORANDUM

Whereas, Sh. Chetan Viraj, Junior Engineer(Elect.) while posted in H.P.PWD., Elect. Sub Division Udaipur at Keylong Section, District Lahul Spiti under HPPWD., Elect. Division Mandi has filed CWP No. 1076/2026 –titled as Chetan Viraj Vs. State of HP & Ors. The matter was lastly listed before Hon'ble High Court on 09.01.2026, wherein, following order has been passed:-

4. Learned counsel for the petitioner submitted that the petitioner would be satisfied in case he is permitted to file a fresh representation to the respondent No.2/ Competent Authority for redressal of his grievances and the respondents/Competent Authority is directed to decide the same within a time bound schedule. Learned Additional Advocate General has no objection to this prayer.

5. Having regard to above submissions but without examining the merits of the matter, this petition is disposed by permitting the petitioner to file a fresh representation within two weeks, which shall be decided by respondent No.2 /Competent Authority within six weeks from the date of receipt of the same, in accordance with law. The decision so arrived at, shall be communicated to the petitioner.

Pending miscellaneous application(s), if any, also to stand disposed of.”

And whereas, pursuant to the order passed by the Hon'ble High Court, personal hearing in the matter was fixed for 12.02.2026. On aforesaid date, the applicant has appeared in person and made his oral as well as written statement for his transfer to one of stations of choice mentioned as under:-
