The application for obtaining the tender form will be received upto **01.00 PM** & without EMD tender form will not be accepted, moreover the tender form can be had from this office against cash payment (Nonrefundable) up to 5.00 P.M. on **08.04.2026**.

The earnest money in the shape of National Saving Certificate/ Time deposit accounts/Saving account in any of the Post Office and Banks of Himachal Pradesh duly pledged in favour of the Xen Mandi Division No. II must accompany with each tender. Conditional tender and the tender received without earnest money will summarily be rejected. The earnest money should be attached with application. 14. Valid enlistment/registration of contractor in the appropriate class
 1. Permanent Account Number (PAN)
 2. GST Registration Number
 3. Earnest money in the shape of National Saving Certificate/Time Deposit Account in any Post Office in Himachal Pradesh, or F.D.R. from any Nationalized Bank duly pledged in favour of the Executive Engineer, Mandi Division No. 2, HPPWD, Mandi H.P.
 4. Earnest money and cost of tender form for the above works must be submitted along with the application for purchase of tender form. Applications received without earnest money and cost of tender form shall be summarily rejected.
 5. The offer of the tender shall remain valid for 75 (seventy-five) days after the opening of the tender.
 6. Ambiguous, telephonic, conditional tenders or tenders submitted by fax/e-mail shall not be considered and will be summarily rejected.
 7. The Executive Engineer reserves the right to reject or cancel any or all tenders without assigning any reason.
 8. If the date specified above happens to be a holiday, the tenders shall be processed on the next working day.
 9. The Contractor/Firm must quote their rates both in words as well as in figures, failing which the Executive Engineer reserves the right to accept or reject any or all tenders.

10. Tender forms shall not be issued to those Contractors/Firms whose past performance is not found satisfactory or who have failed to complete previously awarded works within the stipulated period
