ORDER

WHEREAS, Sh. Chandan Sapra was earlier promoted from the post of Jr. Engineer (Mechanical) to the post of Assistant Engineer (Mechanical) under diploma category vide order dated 26-07-2021;

AND WHEREAS, in pursuance of the instructions dated 06.07.2022 & 27.08.2024 issued by the Department of Personnel and in accordance with the provision contained in section 34 of Right of Person with Disabilities (PwBD) Act, 2016, Sh. Chandan Sapra being a person belonging to the PwBD category was awarded promotion to the post of Assistant Engineer (Mechanical) retrospectively w.e.f. 30.05.2018 purely on notional basis vide this department's Notification No. PBW-A-B(2)-3/2026 dated 17th March, 2026;

AND WHEREAS, the matter regarding assigning seniority to PwBD category was taken up with the Department of Personnel who has informed that they have sought clarification from the Ministry of Personnel, PG and Pensions, Department of Personnel and Training, Government of India;


