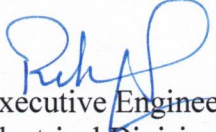

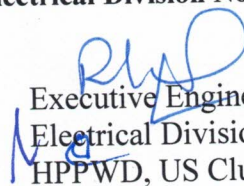

**Expression of Interest for Empanelment of Original Equipment Manufacturers (OEMs) of Lifts/Elevators with HPPWD for Supply, Installation, Testing & Commissioning of Lifts (Category-A & Category-B).**

**1. INTRODUCTION**

The Himachal Pradesh Public Works Department (HPPWD) is the premier engineering department of the Government of Himachal Pradesh, entrusted with the planning, design, construction, and maintenance of public infrastructure throughout the state. Since the attainment of full statehood by Himachal Pradesh in 1971, HPPWD has played a significant role in the development of government buildings and institutional infrastructure across urban as well as remote rural areas in diverse topography and environmental challenges. The present thrust of the Department is to build a sustainable infrastructure with due reduction in carbon footprint and net zero green buildings.

In infrastructure development, HPPWD has expanded its scope in the installation and commissioning of electro-mechanical systems, particularly lifts and elevator systems in multi-storey government buildings, hospitals, educational institutions, and office complexes. The department undertakes installation of various categories of passenger, stretcher, service, and goods lifts as per project requirements and applicable safety standards. At present, approximately more than 100 lifts of different capacities and specifications are being installed annually across the state under various building projects executed by HPPWD.

With its extensive technical expertise, experienced engineering workforce, and commitment to quality infrastructure development, HPPWD continues to make significant contributions to the socio-economic growth and modernization of Himachal Pradesh.

**2. OBJECTIVE**

To further strengthen and promote transparency within the Himachal Pradesh Public Works Department (HPPWD), the department intends to invite Expression



of Interest (EOI) applications from reputed and eligible Original Equipment Manufacturers (OEMs) of lifts/elevators for empanelment for the execution of lift/elevator works in various government buildings.

The empanelled OEMs shall be eligible to participate in tenders for the Design, Manufacture, Supply, Installation, Testing and Commissioning (SITC) of lifts/elevators and associated maintenance works.

The empanelment process shall broadly be governed by the following provisions, as amended from time to time:

- CPWD Works and Procurement Manuals
- National Building Code (NBC-2016)
- BIS / IS Standards IS-17900
- General Financial Rules (GFR-2017)
- HP Lift Act, 2007 and HP Lifts, Escalators & Travelators (1st Amendment) Act, 2025
- HP Lift Rules, 2009

Empanelment shall not confer any right or guarantee for award of work.

### **3. JURISDICTION**

The empanelment shall be valid for execution of lift works in Government buildings under the jurisdiction of Himachal Pradesh Public Works Department across the State of Himachal Pradesh.

### **4. APPROVING AUTHORITY**

The Engineer-in-Chief, HPPWD shall be the approving authority for empanelment of Lift OEMs.

### **5. CATEGORIES OF EMPANELMENT**

Lift OEMs shall be empanelled under the following categories:

#### **5.1 CATEGORY-A (MAJOR LIFT MANUFACTURERS)**

Category-A shall consist of large and established OEMs having significant manufacturing capacity and nationwide service network.

OEMs under this category shall be eligible for lift works in:

- High-rise hospitals buildings having height above 15 metres
- Prestigious Government buildings
- Buildings of National Importance
- Office buildings exceeding G+4 floors
- Commercial and institutional buildings requiring specialized lift systems

## **5.2 CATEGORY-B (STANDARD LIFT MANUFACTURERS)**

Category-B shall consist of medium scale lift manufacturers capable of installing standard lifts in medium height buildings.

OEMs under this category shall generally be eligible for lift works in:

- Office buildings up to G+4 floors
- Other non-residential buildings having height up to 15 metres
- Commercial Buildings of medium height
- Shopping Complexes/Mini Commercial Complexes
- Standard Government buildings requiring conventional passenger having height up to 15 metres

## **6. SCOPE OF WORK**

Empanelled OEMs shall be eligible for execution of following works:

- Design, manufacture, supply and installation of lifts
- Testing and commissioning
- Comprehensive Maintenance Contract (CMC)
- Annual Maintenance Contract (AMC)
- Modernization and replacement of lifts
- Breakdown maintenance services
- Supply of genuine spare parts



## **7. GENERAL PROCESSING FEE**

A non-refundable registration fee of ₹5,000 shall be deposited in favour of the designated authority.

## **8. PERIOD OF EMPANELMENT**

The empanelment shall initially remain valid for a period of two (02) years and may further be extended up to two (02) additional years on a yearly basis, subject to satisfactory performance.
