ORDER

WHEREAS, Sh. Vijay Kumar Verma, Assistant Engineer (Civil) was considered for promotion to the post of Executive Engineer (Civil) by the Departmental Promotion Committee (DPC) in its meetings held on 19.09.2023 which further reviewed on 15.05.2024 but owing to pendency of Departmental Proceedings against him w.r.t. collapse of Baner Bride over Jalari Khad, Distt. Kangra, the recommendation made by the DPC in respect of said officer was placed in a sealed cover;

AND WHEREAS, the above disciplinary proceedings were concluded when the charges leveled against Sh. Vijay Kumar Verma, Assistant Engineer (Civil) vide Memorandum number PBW-A-B(14)-1/2023 dated 17.07.2023 were dropped vide order dated 10.06.2026;

AND WHEREAS, consequent upon conclusion of disciplinary proceedings against the officer as well as issuance of Vigilance Clearance Certificate by the Vigilance Department vide letter dated 25.06.2026, the recommendation of Departmental Promotion Committee in respect of Sh. Vijay Kumar Verma, Assistant Engineer (Civil), which were placed in sealed cover, has been opened;

AND WHEREAS, on perusal of recommendations placed in the sealed cover, it is found that the Departmental Promotion Committee has recommended the name of Sh. Vijay Kumar Verma, Assistant Engineer (Civil) for promotion to the post of Executive Engineer (Civil) with further recommendation to place him above the name of Sh. Chaman Lal (Sr. No. 64) in the panel drawn for promotion to the post of Executive Engineer (Civil). Since, the promotion order of Sh. Chaman Lal was issued vide this department notification(s) dated 22.09.2023 which further modified on 07.06.2024, therefore, the promotion order of Sh. Vijay Kumar Verma, Assistant Engineer (Civil), on notional basis, is required to be issued in continuation of said notification and he is to be placed at Sr. No. 63A above Sh. Chaman Lal (Sr. No. 64); and

NOW THEREFORE, the Governor of Himachal Pradesh is pleased to order the promotion of Sh. Vijay Kumar Verma, Assistant Engineer (Civil) (D.o.B. 05.05.1969) to the post of Executive Engineer (Civil) on regular basis w.e.f. 22.09.2023 on notional basis till actual date of joining. Further, the name of said officer will appear above Sh.Chaman Lal (Sr. No.64) and below Sh. Lalit Grover (Sr. No. 63) in the promotion order issued vide this department notification number dated 07.06.2024. The Governor of Himachal Pradesh is further pleased to post him upon his promotion as Executive Engineer (Civil), HPPWD Division, Jaisinghpur, Distt. Kangra and he will assume new assignment at his present place of posting within 5 days positively under intimation to this department.


