It is also clarified that the instruction of CPWD that "No departmental charges are to be levied for Government works and those of autonomous bodies fully funded by State/Central Government. For works done by HPPWD other than above, departmental charges are to levied".

You are, therefore requested to direct the field units working under your control to adhere the instruction and take necessary action in the matter subject to completing of all codal formalities procedurally in advance to avoid unnecessary litigation in later stage.
