Subject:- Regarding Non-Transfer of Census functionaries appointed for Census 2027.

Madam/Sir,

I am directed to refer to the subject cited above and to say that as you are aware, the preparations for conduct of Census 2027 are at advanced level and it will be conducted digitally in two phases alongwith the provision for self-enumeration as under:-

1. Ist phase is House listing & Housing Census which will be conducted from 16th June 2026 to 15th July 2026;
2. 2nd phase is Population Enumeration which shall be conducted in February, 2027(except the snow bound areas of the State where it would be conducted in September, 2026).

The process of appointment of Census Officers at the level of the State, District, Tehsil and Enumeration Block including appointment of approximately 18,600 Enumerators & Supervisors . 420 Field Trainers and 20 Master trainers has already commenced in the State and training of these Census functionaries is going on across the State. Since, these Census functionaries are required to discharge statutory functions under the Census Act, 1948 and Census Rules, 1990, hence, it is important that once appointed, the aforesaid Officers/officials may not be shifted till the entire Census Operation is over. Accordingly, after detailed deliberations, it has been decided that all those Census functionaries who have been appointed for Census 2027 shall not be transferred untill 31st March, 2027.




