**Subject: The Cabinet's approval for updation of Pradhan Mantri Gram Sadak Yojana (PMGSY) to allow revision of the core network to include Left out habitations- Follow up action**

Sir/Madam,

As you are aware that project proposals under Pradhan Mantri Gram Sadak Yojana (PMGSY) are considered on the basis of the Core Network finalised in 2003 as per Census of 2001. A habitation needs to be part of the Core Network for consideration under the programme. Many States had brought to notice the fact that some habitations were left out, because of inadequacies in the survey and another reasons, from inclusion in the Core Network at the time of its preparation.

2. Taking into account that inclusion of such left out habitations, for providing all-weather connectivity to eligible habitations, is necessary to achieve the objective of the PMGSY programme, a proposal on this issue was placed before the Competent Authority which has been approved. In brief revision of the Core Network can be made by inclusion of:
  - (a) Left-out unconnected habitations (as per 2001 census) in Tribal (Schedule-V) areas (other than 82 IAP districts already included) and Blocks adjoining International Borders under Border Area Development Programme (BADP) and to provide new connectivity to these habitations; and allowing upgradation of certain roads measuring about 2,000 km in these areas based on a road condition survey which will define an Upgradation Priority List.

(b) Left out unconnected habitations with population of 250 persons and above (as per 2001 census) in the Hill States of Arunachal Pradesh, Jammu & Kashmir, Himachal Pradesh, Manipur, Mizoram, Meghalaya, Nagaland, Sikkim, Tripura and Uttarakhand and the Desert areas (as identified under DDP) to provide new connectivity to these habitations;

(c) Left out unconnected habitations with population of 500 persons and above (as per 2001 census) in plain areas to provide new connectivity to these habitations.

3. As the Pradhan Mantri Gram Sadak Yojana (PMGSY) is executed by the States/UTs, the following actions are required to be taken up by the States/UTs to revise their Core Network:-

3.1 With reference to the decisions as above, respective States should work out detailed proposal for revision of their Core Network in respect of left out Habitations which are other-wise eligible for connectivity (as per census 2001) following the prescribed procedure and send the same to NRRDA alongwith supporting documents and updating on OMMAS after duly scrutinized by concerned STA.

3.2 As regards, Upgradation of certain roads measuring about 2,000 km in Tribal (Schedule-V) areas (other than 82 IAP districts already included) and Blocks adjoining International Borders under Border Area Development Programme (BADP), the concerned States/UTs need to carry out a road condition survey to determine an Upgradation Priority List of the same. The Priority List alongwith road condition survey report will be send by the concerned States/UTs to NRRDA for their scrutiny and preparation of a consolidated proposal according to State-wise targets out of the 2,000 km road length to the Ministry.

This issues as per the approval of the Cabinet in its meeting held on 07<sup>th</sup> February, 2013.
