Sir/Madam,


I am directed to invite your attention to the subject cited above and to say that the Himachal Pradesh Public Service Commission is in the process of implementing the DigiLocker facility for candidates, as requested by National e-Governance Division Ministry of Electronics and Information Technology, Govt. of India, for integration of DigiLocker into the State Public Service Commission. Under this facility, candidates will be able to fetch their documents directly from DigiLocker and upload the same against their respective qualifications, categories or sub-categories while filling up online application forms. The availability of digitally verified documents will not only facilitate candidates but also enhance transparency, reduce manual verification, and expedite the recruitment process, thereby promoting further advancement in e-Governance.

It is, therefore, requested that the DigiLocker facility be implemented across all certificate-issuing agencies, Colleges and Universities functioning under the administrative control of the Departments. These institutions may be directed to mandatorily upload all relevant certificates and documents issued by them on the DigiLocker platform. This will facilitate


