TERMS AND CONDITIONS

1. The above rates are FOR destination in HP for all destinations inclusive of all taxes including Excise Duty, Sale Tax, HP Road Tax, HP Entry Tax, Handling/Packing/Loading/Freight charges, Transit Insurance etc. However any statutory increase/decrease in Taxes and Duties if levied by the HP Govt. shall be paid as extra or less as the case may be.
2. **Payment:** - 100% payment shall be made within 30 days from the receipt of material by the consignee in good condition through Bank Draft in favour of firm and Bank charges will be deducted from the Bill of firm.
3. **Training:**-Regarding use/application of Emulsion based explosive training is required to be imparted at circle level in the State of Himachal Pradesh without any extra cost whatsoever, whenever it is required.
4. **Warranty:**- In case any item of explosives, if found defective /wanting at any time during and up to a period of six months from the date of supply of the same shall be replaced by the firm at destination without any extra charges.

5. The material should be supplied within 30 days from the receipt of form "RE-11" from the consignee after placement of supply order. In case the material is not supplied within the stipulated period then the Earnest money of Rs. 2.00 Lacs (Rs. Two Lacs) only deposited with the Department shall be forfeited.
6. Supply of material will be made according to the capacity of magazine after getting delivery schedule of material, License No. and capacity of magazine from consignee concerned.
7. The safe delivery of consignment is the sole responsibility of the supplier and no claim regarding deployment of guards during transit shall be entertained.
8. All other terms and conditions supplied/agreed as per NIQ shall hold good during the period of supply i.e. up to 31/03/2016 or if any period is extended further. In case, any item of explosive material later on, if found to be on rate contract of Controller of Stores of HP or DGS&D at the time of procurement at lesser rate then the material shall likely to be procured by the Department from the sources approved in the rate contract and no claim, whatsoever will be entertained from the supplier on this account.
9. Any dispute arising shall be settled within the jurisdiction of HP High Court.
