OFFICE MEMORANDUM

Subject: Final seniority list of Superintending Engineers (Civil) HP Public Works Department showing the position as on 30.9.2015.

A tentative seniority list of Superintending Engineers (Civil) HPPWD indicating the position as on 30.9.2015 was circulated amongst the concerned Superintending Engineers (Civil) for inviting objections, if any, vide this Department Office Memorandum of even number dated 29.10.2015.

Against the said tentative seniority list Sh.Naresh Kumar Vashist, SE Nahan, and Sh.Kehar Singh Thakur, SE Rampur Bushahr have submitted their objections. Sh.Naresh Kumar Vashist vide his representation dated 17.11.2015 has submitted that in the tentative seniority list his date of birth be corrected as 23.7.1960 instead of 23.6.1960. The objections has been found valid and as such his date of birth has been corrected.

Sh.Kehar Singh Thakur vide his representation dated 21.11.2015 has submitted that for the sake of natural justice he may be assigned seniority as SE either from the date of availability of vacancy of SE on 1.3.2013 or from the date he was given charge of the post of SE i.e.20.4.2013. He has justified his claim on the ground that vacancy of SE was available in the Department as on 1.3.2013 but the promotion process was wrongly stopped in the light of DOP notification dated 11.1.2013 after interim order passed by the Hon'ble Supreme Court in SLP No.30143/2009 on 7.1.2013 as there is no reservation quota for SC/ST in our State from Class-I to Class-I category promotion. He was given charge of SE on 20.4.2013 but promoted on regular basis vide notification dated 18.11.2013. In this connection, it has been found that promotion is given prospective effect from the date the order of promotions are issued on the recommendation of the DPC. In the present case, vide notification dated 20.4.2013, Sh.Kehar Singh Thakur, EE was transferred from ENC office and posted as EE in 1st

Circle Mandi against the vacant post of SE with the stipulation that he will look after the work of the post of SE in his own scale without any remuneration, therefore, this was an internal arrangement which does not confer any right of promotion or seniority to the officer. Moreover, 2 other EEs (Sh.Ashwani Kumar Abrol & Sh.Bhawan Kumar Sharma) were also directed to look after the work of SE vide this same notification, who have not represented for such a benefit as has been sought by Sh.Kehar Singh Thakur. They all have been given regular promotion as SE vide notification dated 18.11.2013, as such, Sh.Kehar Singh Thakur and others have been shown promoted to the post of SE as on 18.11.2013. Therefore, the representation of Sh.Kehar Singh Thakur has no merit and the same is rejected.

Now, therefore, in view of the above, the tentative seniority list circulated vide this Department's Office Memorandum of even number dated 29.10.2015 is hereby finalised (Annexure-A). No representation on any ground except clerical and patent errors shall be entertained.


