

Narender Chauhan dated 15.10.2014, the entire excess amount shall be recovered by the Govt. Besides, the instructions issued by FD vide No. 01.08.2012, 09.08.2012 and 29.12.2015 may also be kept in view while fixing pay of the above incumbents.


