ORDER

Whereas Shri Sushil Kumar, Executive Engineer (Civil) was posted as Executive Engineer, Municipal Corporation Dharamshala and was transferred to HP,PWD Division Dharamshala, (District Kangra) vide this department Notification of even number dated 06.12.2018 vice Shri Ajay Sharma, Executive Engineer (Civil), HP,PWD Division Dharamshala, District Kangra.

Whereas, feeling aggrieved with the above transfer orders, Shri Ajay Kumar, EE filed an OA. No. 7255/2018 in the Hon'ble H.P. Administrative Tribunal, Shimla, Hon'ble Administrative Tribunal while disposing of the OA vide its order dated 31st December, 2018 passed the following directions:-

"Filing of replies is dispensed with. With the consent of the parties, the present original application is taken up for disposal at this stage. In the facts and circumstances and interest of justice, the original application is disposed of with the stipulation that subject to the applicant making a detailed representation, supported by documents alongwith certified copy of this order, taking all the grounds as set up in the original application, to respondent No.1, through the Additional Chief Secretary (PW) to the Government of Himachal Pradesh, within three days from today, who shall consider and decide the same in accordance with law, sympathetically, and the transfer policy framed by the State Government, by 31st December, 2018 after affording an opportunity of being heard to the applicant as well as private respondent No. 2."

Whereas, the personal hearing has been fixed for 29.01.2019 and both incumbents have been presented and heard in person. The applicant Shri Ajay Kumar, EE submitted that he is being transferred time and again and since his joining the service he had served at the various stations and therefore requested that he may be either allowed to continue at present place of posting as EE, Dharamshala, HP, PWD Division or may be adjusted in the vicinity of Kangra. Further, Shri Ajay Kumar, EE indicated his choice of posting Station to newly created HP,PWD Division, Bhawarna, District Kangra against vacancy.

Shri Sushil Kumar, EE (Civil) has submitted that since he has joined as EE, HP,PWD Division Dharamshala only one and half month ago, therefore, he may be allowed to continue as such.

Now therefore, after due consideration of the facts and circumstances submitted by both the Officers, Shri Ajay Kumar, Executive Engineer (Civil) is ordered to be posted/adjusted at newly created HP,PWD, Division Bhawarna, District Kangra against vacancy in the public interest. Hence, his representation is hereby disposed off. All concerned be informed accordingly.
