In pursuant to approval conveyed vide Principal Secretary (PW) to HP Govt. letter No. Per. PBW-AB (1)-4/2009- Loose dated. 28.12.2011 and further on the recommendations of Himachal Pradesh Directorate of Sainik Welfare Ex-Servicemen Employment Cell Hamirpur letter No. DSW Ex Cell OC-18/2014 dated 01.08.2014, the following ex-servicemen are hereby offered appointment as Surveyor on contract basis in the pay scale of Rs. 5910-20200 + 2400 Gr. Pay with initial start of Rs. 8310/- PM and posted as mentioned below against each:-

The above appointments have been ordered subject to the following terms and conditions:-

The appointment shall be on contract basis initially for a period of one year from the date of joining the post, but contract can be reviewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without notice.

1. The contractual appointee will be paid fixed contractual amount @ Rs. 8310/- per month (which shall be equal to minimum of pay band + Grade Pay). The contract appointee will be entitled for annual increase in contractual amount i.e. @ 3% of (Minimum pay band + Grade Pay) for the subsequent year(s).
2. His appointment shall be subject to the production of Medical Certificate of fitness from the Distt. Medical Officer of the Govt. Hospital.
3. The appointment shall further be subject to terms and conditions of attached agreement and surety Bond for Rs. 10,000/- on Non-judicial paper

4. He should give a declaration that he has got only one living wife, (if married).
5. He is liable to serve in any part / Area where HP PWD has its organization.
6. He is required to produce antecedent verification certificate to the satisfaction of the department from the First Class magistrate or two Gazetted officers known to him at least for last five years.
7. He is also required to produce all original certificates in support of his qualification/technical education, age, Himachali bonafide and belonging to any reserved Class against which He is proposed to be appointed at the time of joining the post. He will have to produce assets & liability return before joining the post.
8. He will be entitled for 12 days casual Leave, 5 days special leave and 10 days medical leave in a year and no other leave will be admissible other than Gazetted holidays and Sunday. He will not be entitled for Medical Reimbursement and LTC etc.
9. Provisions of service rules like FR SR, Leave Rules , GPF Rules, Pension Rules & conduct Rules etc. as applicable in case of regular employees will not be applicable in case of contract appointees. Continuation of contract on year to year basis will be based on his performance and conduct. His services can be terminated prematurely without assigning any reason on one month notice or with one month wages.
10. He will also have produce NOC from the department/organization, if he has worked on regular/contract/daily wage basis prior to this appointment.
11. Transfer of the contract appointee shall be permitted after the completion of 3 years.
12. He will be entitled to TA/DA if required to go on tour in connection with her official duties at the same rate as applicable to regular appointee.
13. The employee's group insurance scheme, EPF and GPF will not be applicable to him/her.



14. He will require to take oath/affirm on the following form:-

I _____ do swear /solemnly affirm that I will be faithful and either bear true allegiance to the constitution of India as by laws established and that I shall carry out the duties of my office with loyalty, honesty and impartiality

If He accepts the offer on the terms and conditions given above, he should report for duty to the officer as mentioned in Column NO-4 above within a period of one month, failing which the offer shall be cancelled automatically.
