

The merger of Receptionists and Store Clerks have been ordered subject to the following terms and conditions:-

1. The incumbents who opted for merger will be placed at the bottom in the seniority list of clerks.
2. The inter-se-seniority of above incumbents amongst themselves would be determined purely in accordance with their service particulars.
3. The offer is subject to condition that their character antecedents are found satisfactory if not verified earlier.
4. Their pay will be protected and past service will be counted towards pension benefits (where applicable).
5. The cadre of Store Keepers and Receptionists have been declared as dying cadre in respect of those incumbents who do not opt. for the merger and the posts will be abolished as and when the incumbents cease to hold these posts.
6. Neither any new creation nor any filling up of the posts would be made on this account in further.
7. Other conditions of services will be governed by the relevant rules/orders from time to time.

In case the above Terms and Conditions for merger are acceptable to the aforesaid officials, they may submit their joining report to the officer, as mentioned in column No-4 above within 10 days positively failing which this offer shall stand cancelled.


