ORDER

Whereas, Sh.Munish Sharma, was appointed as Junior Enigneer (Civil) in HPPWD on 28.7.1997 and was selected as Assistant Engineer (Civil) in I&PH Department, HP on 1.7.2012.

Whereas, Sh.Munish Sharma, was relieved from the HP,PWD on 9.8.12 and his lien was retained for a period of two years i.e. upto 8.8.2014 (AN) with the condtion that after the expiry of two years, he had to revert back to his parent department and in case, his reversion does not take place, he will have to resign from the post of Junior Engineer as per undertaking given by him. However, after receipt of request from Sh.Munish Kumar, his lien was extended further for another one year i.e. 9.8.14 to 8.8.15 with the condition that in case, his reversion does not take place, he will have to resign from the post of Junior Engineer as per under taking given by him.

Whereas, Sh.Munish Sharma, neither revert back to his parent department nor tender resignation from the post of Junior Engineer after the expiry of lien period on 8.8.15 and made a representation on 20.11.2015 i.e. after 03 months of expiry of lien period for extension of his lien for a further period of 02 years i.e 9.8.15 to 8.8.17 on the grounds that his future prospects and promotion scope are better in HPPWD and he is ready to come back to his parent department on his promotion.

And whereas, representation dated 20.11.15 was examined in this department and it was found, that on the one hand, the officer wants to enjoy the status of Assistant Engineer and financial benefits in I&PH Department and on the other hand, requesting for extension in lien for a further period of two years to wait and watch that in which department he will get better promotional opportunity so that he can continue in that department. Hence, the request made by the officer for extension of his lien period for two years i.e. 9.8.15 to 8.8.17 was not found satisfactory and the same was rejected and conveyed to him with the request to submit resignation from the post of Junior Engineer as per undertaking given by him at the time of relieving from the parent department on 8.8.12.

And whereas, Sh.Munish Sharma, instead of tendering resignation form the post of Junior Engineer, again made request vide his representation dated 8.3.2016 for re-consideration of extension of lien for further period of 02 eyars w.e.f. 9.8.15 to 8.8.17 or for a period till his promotion in HP,PWD. In the said representation no new facts has been stated by the officer and are the same, as has been made in representation dated 20.11.15. However, a personal hearing was granted to him on 26.5.16 at 11.00 AM to explain his postion. But the officer did not put forth some reasonable justification before the undersigned for extension of his lien period. Hence, there is no merit in the reprepresentation dated 8.3.16.

Now, therefore, in view of above facts and circumstanaces, the representation dated 8.3.2016 made by Sh.Munish Sharma, Assistant Engineer (I&PH) to extend his lien in HP,PWD for a further period of 02 years i.e. 9.8.15 to 8.8.17 or till his promotion, has no merit, and the undersigned hereby reiterate the rejection as has been conveyed to him vide this department letter of even number dated 21st December, 2015.
