3. The above officer shall exercise option under FR-22 within a period of one month from the date of issue of this order for fixation of pay against the post of Assistant Engineer (Civil).
4. If the promotion is acceptable to the above Officers, they are directed to send the charge assumption report to the undersigned, within 10 days, failing which, their promotion order shall stand withdrawn and next person in line be offered promotion on similar conditions.
