ORDER

Whereas, Sh.Virender Sambyal, (D.O:B.1.5.64) was appointed as Junior Engineer (Civil) in Himachal Pradesh Public Works Department on 18.11.1989 and after applying through proper channel, he was appointed as Assistant Engineer (Civil) in HP,PWD on 8th March, 2000.

And whereas, the services of Sh. Virender Sambyal, Assistant Engineer (Civil) were placed on deputation basis in National Highway Authority, New Delhi on 17.1.2004 and while working on deputation basis, Sh.Virender Sambyal, made a request to this department on 15th December, 2009 to forward his application to the National Highway Authority of India, New Delhi for his permanent absorption against the post of Manager (Tech.). Accordingly, his application was forwarded to the General Manager (HR-II), NHAI, New Delhi vide this department's letter No.PBW-A-B(12)-8/2003 dated 6th January, 2010 for his permanent absorption.

And whereas, Sh. Virender Sambyal, was appointed as Manager (Tech.) in National Highway Authority of India on absorption basis and was relieved from the Government service vide office order No.PWE-139-3 (Transfer/Posting)ES-II/2013 dated 14th January, 2013 with immediate effect to join his duties in NHAI, New Delhi where he joined on 15th January, 2013 (F.N.).

And whereas, vide representation dated 12th January, 2015, Sh. Virender Sambyal, has made representation to this department that he is not willing to join back in the HP, Public Works Department, therefore, his technical resignation be accepted and all pensionary benefits viz pension, gratuity, earned leave encashment, GPF, GIS etc. may be released in his favour.

And whereas after going through the record of the case, it evident that National Highway Authority of India is a autonomous body and there is no CCS (Pension) scheme. Therefore, request made by Sh. Virender Sambyal vide representation dated 12th January, 2015, his technical resignation deemed to have been accepted w.e.f. 15.1.2015 (F.N.).

Now, therefore, the Governor, Himachal Pradesh is pleased to order that Sh.Virender Sambyal shall be deemed to have retired from service from the date of his absorption and he shall be eligible to receive retirement benefits w.e.f. 18.11.1989 upto date of absorption i.e. 15.1.2013 under Rule 37 of CCS (Pension) Rules, 1972 on account of service rendered by him in HP, Public Works Departments.
