The appointment shall be on contract basis initially for a period of one year from the date of joining the post, but contract can be reviewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without notice.

The contractual appointee will be paid fixed contractual amount @ Rs. 7810/-per month (which shall be equal to minimum of pay band +Grade Pay). The
