- 1. They are entitled for the pay scale of Rs. 5910-20200 plus Rs. 1900/- Grade pay, and fixation of pay will be done under the provision of normal rules. They shall be entitled for other allowances whatsoever are admissible to the employees of State Government from time to time.
- 2. The regularization shall be subject to verification of character and antecedents, as provided by the HP financial Rules.
- 3. Their appointment shall be subject to the production of Medical Certificate of fitness from the Distt. Medical Officer of the Govt. Hospital.

- 5. They are required to produce antecedent verification certificate to the satisfaction of the department from the First Class magistrate or two Gazetted officers known to them at least for last five years.

- 6. They are also required to produce all original certificates in support of their qualification/technical education, age, Himachali bonafide and belonging to any reserved Class against which they are proposed to be appointed at the time of joining the post.
- 7. Their services can be terminated prematurely without assigning any reason on one month notice or with one month wages.
- 8. They shall have to submit assets & liability statement.
- 9. They will have to pass type test as prescribed in the R&P Rules.
