Narender Chauhan dated 15.10.2014, the entire excess amount shall be recovered by the Govt.

Note(2): - That the instructions issued by FD vide No. 01.08.2012, 09.08.2012 and 29.12.2015 may also be kept in view while fixing pay of the above incumbents.
