The above regularization are subject to the following

- 1. He will draw Pay in the pay Band Rs.10300-34800+3800 Grade pay, and fixation of pay will be done under the provision of normal rules. He She shall be entitled for other allowances whatsoever are admissible to the employees of State Government from time to time.
- 2. He will have to produce original Certificates of his Academic/ Technical qualification at the time of joining the appointment.
- 3. His age at the time of joining the post should neither be less than 18 years nor more than 45 years. It is relaxable by five years in the case of Schedule Caste/Schedule Tribe classes.
- 4. The regularization shall be subject to verification of character and antecedents, as provided by the HP financial Rules.
- 5. His appointment shall be subject to the production of Medical Certificate of fitness from the Distt. Medical Officer of the Govt. Hospital.
- 6. He is liable to serve in any part / Area where HP PWD has its organization.
- 7. He is required to produce antecedent verification certificate to the satisfaction of the department from the First Class magistrate or two Gazetted officers known to him/her at least for last five years.
- 8. He is also required to produce all original certificates in support of his/her qualification/technical education, age, Himachali bonafide and belonging to any reserved Class against which he/she is proposed to be appointed at the time of joining the post.
- 9. His services can be terminated prematurely without assigning any reason on one month notice or with one month wages.
- 10. He shall have to submit assets & liability statement.
- 11. In case he wishes to resign, he will serve at least one month notice to enable the Department to make arrangement for his substitute. The discretion to accept or to reject his resignation will rest with the appointing authority but in no case he shall be relieved from his charge until and unless the resignation is finally accepted by the competent authority. In case of any failure on part of official on this account he will be liable for disciplinary action and will be permanently debarred from Govt. service in future.

12. He should give a declaration that he has not more than one living wife.

- 13. He will be governed by the CCS & CCA conduct Rules.
- 14. He will have to give in writing whether he was ever convicted by the criminal court and if so the particulars of offence and punishment be stated, failing to disclose the facts, he will render himself liable to be removed from service without any notice as and when factual facts come to light/notice.

15.In case of any of the certificate /information produced /information produced/given by the candidate is found false /wrong, lateron his services will be terminated.
