“OFFICE ORDER”

On the recommendations of the departmental promotion committee, the following Kanungos working in the pay scale of Rs:- 10300-34800+GP.4200, are hereby promoted to the posts of Naib Tehsildars in the pay scale of Rs:- 10300-34800+GP. 4800 on regular basis from the date of their actual joining the posts:-

The above promotions to the post of Naib Tehsildar are subject to the final outcome of the O.A. No. 5826 of 2018, Suresh Sharma Vs State of HP & others pending in the Hon'ble HP. Administrative Tribunal Shimla-2.

Before the above orders are implemented, the concerned Head of the office will ensure that the promotees fulfil the appended conditions:-


1. The above promotees will join at the place of his/her posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. which ever is later. No specific orders with reference to withdrawal of promotion will be issued separately.
2. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if some one applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting /appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
3. The above promotion is subject to review due to any consequential administrative reasons.
4. Those who have been posted outside the sub-cadre/Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.



5. That in case of any factual error/omission is detached later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promote before they are relieved on promotion to the next station.
6. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official.
7. Their academic qualification & departmental examination certificates may also be verified before relieving.
8. The financial benefit will be admissible to the promotees from the date of joining and their pay will be fixed as per the provision of FR-22 (i)a(i) for which they can exercise their options for fixation of their pay within one month from the date of joining.
