The above appointments have been ordered subject to the following terms and conditions:

The appointment shall be on contract basis initially for a period of one year from the date of joining the post, but contract can be reviewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without notice.

- I. He/She will be paid consolidated monthly emoluments i.e Basic Pay+Grade Pay and 50% of Grade Pay, per month. He/She shall not be entitled for any other allowance whatsoever is admissible to the employees of State Government from time to time.
