WHEREAS, Shri Rattan Kumar Sharma, Assistant Engineer (Civil) was considered for promotion to the post of Executive Engineer (Civil) by the Departmental Promotion Committee held on 02.04.2015 in HP Public Service Commission but owing to the pendency of disciplinary proceedings, the recommendations made by the DPC were placed in sealed cover.

2. **WHEREAS,** the disciplinary authority has exonerated the said Sh. Rattan Kumar Sharma of the charges leveled against him vide order No. PBW-A-A(5)-15/2011-Vol.I dated 07.07.2018 and consequently recommendations made by the Departmental Promotion Committee, placed in sealed cover were opened.


3. **WHEREAS,** the Departmental Promotion Committee has recommended the name of Shri Rattan Kumar Sharma for promotion to the post of Executive Engineer (Civil). It has further been recommended to place the name of Shri Rattan Chand Sharma in the seniority list below Shri Jeet Singh and above Shri Atul Jyoti who have already been promoted to the post of Executive Engineer (Civil) on adhoc basis vide notification No. PBW (A)B(6)-13/12-II dated 07.05.15.

Now, therefore, the Governor, Himachal Pradesh is pleased to order the promotion of Shri Rattan Kumar Sharma to the post of Executive Engineer (Civil), Class-I (Gazetted) in the pay scale of Rs. 15,600-39100+Rs. 7600 (Grade Pay) on adhoc basis w.e.f. 07.05.2015. However, the said promotion will be notional w.e.f. 07.05.2015 to 26.06.2016 and thereafter w.e.f. 27.06.2016 on actual basis. In the seniority list his name shall be placed below Sh. Jeet Singh and above Sh. Atul Jyoti.

5. The officer shall continue to work at his present place of posting and shall submit his joining report immediately. However, the said promotion
