



8. He/she will produce medical certificate of fitness signed by the Chief Medical officer indicating specifically whether he/she is suffering from any communicable disease or not.
9. If he/she has worked anywhere in any capacity, he should bring a clearance certificate from the authorities concerned before he can be permitted to take up the appointment in the department.
10. He/she should produce a certificate of approved character from 1<sup>st</sup> Class Magistrate or from two Gazetted Officers known to him at least for the last three years.
