ORDER

Whereas, Sh.Rajesh Kumar, Junior Engineer (now Assistant Engineer) while working as such in HP,PWD Division, Sangrah was assigned the charge of the post of Assistant Engineer, HPPWD Sub-Division, Dodrakwar on 8.8.2013 in his own pay scale without any extra remuneration. The official was relieved from HPPWD Division, Sangrah on 29.9.2013 to join his duties in Sub-Division, Dodrakwar. However, the official neither joined in Sub-Division, Dodrakwar nor give any intimation for non joining in Dodrakwar. Thereafter, after the approval of higher authorities, his order were modified and posted as Engineer Officer, HPPWD, Circle Nahan on 25.8.14, where he joined on 30.9.2014.

Whereas, Sh.Rajesh Kumar, has applied for medical leave w.e.f. 19.9.2013 to 29.8.2014 (345) days alongwith medical certificate issued by the Medical Officer, Zonal Hospital, Nahan w.e.f. 19.9.13 to 22.10.13 and private Hospital i.e. Nirmal Health Services, Nahan w.e.f. 23.10.13 to 29.8.14..


And whereas, a personal hearing was granted to Sh.Rajesh Kumar on 3.3.2016 at 4.00 PM to explain his position as to why stern action may not be taken against him for remaining absent without any intimation. However, after hearing the official, the Chief Medical Officer, Nahan, Distt. Sirmour was requested vide this department letter of even number dated 11.3.16 to medically examine the officer so that veracity of his claim could be confirmed. The Chief Medical Officer has submitted his medical report vide his letter No.HFW-N/G.A.-1/2015-10255 dated 29.3.2016. As per the medical report, the official is suffering from Hypertension and depression with some psychotic disorder for which he needs regular treatment by a psychiatrist and physician.

And whereas, as per the instruction issued by the Health department vide notification dated 19th July, 2006, the medical certificate issued by the un-recognized private hospital are not valid.

Now therefore, in view of facts and circumstances of the case, the undersigned, hereby orders to sanction medical leave w.e.f. 19.9.13 to 22.10.13 (34 days) for which official has submitted medical certificate issued by the Medical Officer, Zonal Hospital, Nahan. However, the period w.e.f. 23.10.13 to 29.8.2014 (311 days), for which official has submitted medical certificate issued by private hospital i.e. Nimral Health Service, Nahan, shall be treated as dies non, which shall neither be counted as service nor break in service. Further, the official is warned to be more careful in future, failing which disciplinary proceeding will be initiated against him.




