In continuation of this Department letter number Per (AP)-C-B (2)-3/2012 dated 28th June, 2014, I am directed to say that the matter regardingregularization of services of contractual employees working in various Departments was under consideration of the Government for some time past. Now, it has been decided by the Government to regularize the services of the contractual appointeesafter completion of five years service as on 31-03-2015, provided that they have been engaged, as such, after observing all codal formalities, subject to the following terms

and conditions:-

- The contractual appointees will be eligible for regularization only against the 1.
- The regularization will be strictly on the basis of seniority subject to conditions that eligibility criteria etc. prescribed in the Recruitment and 2. Promotion Rules for the post have been observed at the time of their initial
- The candidate should be medically fit for the post against which he/she is being considered for regularization. Obtaining the Medical fitness certificate 3. of the candidate shall be ensured in accordance with the provisions contained
- The regularization shall be subject to verification of character and antecedents in FR 10 and SR 4 (1), 4 (2) and 4 (3). of the candidate being considered for regularization as provided in the H.P. 4.

For the determination of date of birth of the candidate concerned, the criteria as laid down in Rule 7.1 of the H.P. Financial Rules Vol.-I Hand-Book No. 2 5.Contd. at P/-2 ... shall be observed.
