Before accepting the joining reports of above promotes their original Diploma/ I.T.I. Certificates in the trade of Mechanical/Automobile/Production/Aeronautical/Marine Engineering or its equivalent from an Institution/University duly recognized by the Central or State Govt./in the trade of Motor Mechanic or its equivalent from an ITI or an Institute duly recognized by the State/Central Govt. may be verified by the concerned office. In case, any one of promote does not full-fill the requisite qualification ,his promotion orders may not be implemented and the case is required to be referred to this office.


All the above officials may be relieved immediately failing which it will be administrative lapse and action will be taken against the controlling office.

If any of the promote proceeds on leave to avoid his joining in his new place of posting within stipulated period , disciplinary action will be initiated against the defaulter.

In the event of their not joining the post within stipulated period i.e. within 15 days after the issue of order,, offer of promotion shall be deemed automatically withdrawn without notice and opportunity and next official in the line shall be promoted.

If an official forgoes his promotion then he will be considered for promotion after one year or whenever the post is available, whichever is later.


In the case, any error in the present place of posting of promote occurs, the same may be got rectified in consultation with this office.
