
ORDER

Whereas, the period w.e.f. 8.4.2016 to 24.5.2016 in respect of Sh.Vijay Chauhan, Assistant Engineer (Civil), o/o Engineer-in-Chief, (QC&D), HP,PWD Shimla was ordered to be treated as dies non without break in service on the grounds that during the said period, the officer was not ill ^{and} rather he had tried to put political pressure to get his transfer order cancelled.

Whereas, Sh.Vijay Chauhan, Assistant Engineer has made representation on 25.10.16 and has submitted that he never approached any one to get his transfer order cancelled. The Officer has further submitted that due to illness, he was not in a position to join duty in the office of E-in-C (QC&D), HPPWD Shimla for which he has submitted medical certificate alongwith fitness w.e.f.8.4.2016 to 24.5.2016 issued by Professor & Head, Neuro Surgery Department, IGMC Shimla. Therefore, his representation may kindly be re-considered on sympathetic grounds and commuted leave on medical grounds w.e.f. 8.4.16 to 24.5.2016 may kindly be sanctioned in his favour.

And whereas, after going through the record of the case, the representation of Sh.Vijay Chauhan, Assistant Engineer, has been re-considered and by taking a lenient view, it has been decided to withdraw the order dated 21st September, 2016 and sanction commuted leave on medical grounds in favour of Sh.Vijay Chauhan, Assistant Engineer (Civil).

Now, therefore, in view of above, the order of even number dated 21st September, 2016 is hereby withdrawn and commuted leave on medical grounds w.e.f. 8.4.2016 to 24.5.2016 has been sanctioned in favour of Sh.Vijay Chauhan, Assistant Engineer (Civil) o/o E-in-C (QC&)D, HPPWD Shimla. However, the officer is warned to be more careful in future and not to repeat such thing. All the documents viz leave application, medical certificate etc received vide letter dated 9.8.16 are returned herewith in original.


