Pursuant to direction passed by Hon'ble Tribunal dated 13.12.2016 in OA No. 6723/2016-Rakesh Gupta and ors Vs State of HP & others and Additional Chief Secretary (PW) to the Govt of Himachal Pradesh letter No. PBW-AE(1)-72/2016 dated 30.12.2016, promotion order from the category of Work Inspector who posses ITI course of two years duration in the trade of Surveyors /Draughtsman (civil) having 12 year service to the category of Junior Engineers(Civil) whose particulars, Integrity/VCC and ACRs etc were summoned as per **Annexure A -4** letter No. No. PWE-126-Promotion JE(Civil)ES-III-1822-38 dated 25.11.2016 and whose promotion order were inadvertently issued vide this office order No. PWE-126-Promotion/JE(Civil)/ES-III-12476-12575 dated 29-12-2016 are hereby withdrawn till further order. 
