Before the above orders are implemented, the concerned Head of the office will ensure that the promotees fulfill the appended conditions:-

1. If the above promotion orders in acceptable to the above Junior Engineer (Elect.) on adhoc basis, they are directed to join the new assignment within fifteen days positively and send the joining report to the undersigned, failing which these promotion orders will be withdrawn automatically for one year or till the date of next D.P.C. which ever is later.
